



PARTICIPANT AGREEMENT WITH SIMS/SIMS FOUNDATION – EVENT TERMS AND CONDITIONS

Participant Agreement

I agree to the following as conditions of participating in the Fantasea Harbour Hike event.

I acknowledge that:

a) I participate in the Event at my own risk. I will take all reasonable measures to protect myself from the risks of participation. I accept all responsibility for travel and medical insurance and for payment and/or reimbursement of medical/surgical expenses incurred on my behalf as the result of my participation.

b) I am responsible for all property I bring to the Event sites and that the Sydney Institute of Marine Science and SIMS Foundation (and / or their directors, officers, employees, volunteers, contractors, sponsors and / or agents) accept no responsibility for any loss or damage to this property.

c) I consent to the conduct of identity verification checks, background security checks and any other security checks (which may include inspecting my personal property) prior to my entry to and departure from any Events sites (including the start line, finish area, check-points).

d) I undertake to comply with all reasonable directions and decisions of the officials, and other representatives of SIMS Foundation and Fantasea Harbour Hike staff, volunteers and officials.

In addition I acknowledge I will have no claim against SIMS/SIMS Foundation for any loss or damage I may suffer as a result of such cancellation.
